WELCOME TO OUR DEDICATED NEUROLOGY AND PAIN DIAGNOSIS CENTER.

With our physician's specialized fellowship training in pain and neurology, we are able to assist the patient and referring party in the diagnosis and management of persistent pain problems.

Frequently, these cases may have a nerve injury (neuropathic cause) or structural component that has made diagnosis challenging, e.g., nerve root problem or radiculopathy, spinal cord problem, brachial or lumbosacral plexus problem, carpal tunnel, tarsal tunnel, nerve problem or neuropathy. To address these issues, our approach involves an initial comprehensive, pain *focused* neuro consult, including a detailed history, general physical and neurological examination. Based upon these findings, we are then able to perform an informed and *focused* EMG and electrodiagnostic evaluation.

A successful outcome begins with a timely diagnosis!

The patient's previous studies are then reviewed and correlated with the history and exam findings, to arrive expeditiously at a problem oriented diagnosis—our goal being to determine the location of the most likely source of the pain (pain generator),

and related structural problems that may be responsible for the ongoing pain and disability.

A complete report will then be sent to the referring party, detailing our impressions as well as



any additional diagnostic or treatment recommendations that may be indicated, especially where a more definitive or corrective intervention may be an option.

If the work-up requires further testing or consultation, we will proceed at your direction.

Our focus is - Diagnosis.

So that we may consistently provide timely *new patient* appointments and evaluations, our focus is *diagnosis*, however, pain management and general neurology services are also available.

In addition to neurology and pain consultation, our center provides the following, *on-site*, electrodiagnostic testing:

- Electromyography - Needle EMG
- Pudendal EMG
- Nerve Conduction Velocity Studies - NCVs
- Evoked Potentials Studies - SSEPs
- BAERs, VEPs, Trigeminal & Facial Nerve Studies

As a dedicated *diagnosis* center, we look forward to assisting you



in the care and *timely* evaluation of your pain problem. We are usually able to schedule patients within 10 days

of receiving the referral information. If a more urgent evaluation is needed, inform us of the circumstances and we will make every effort to provide you with an earlier appointment.
